He is also a member of the Judicial Service Commission of Uganda, a constitutional body that appoints regulates and disciplines judicial officers at the Magisterial level and recommends appointments to the Higher Bench. He was Lead Counsel in the key case of Susan Kigula and Others v. Attorney General of Uganda in which the mandatory death penalty sentences were declared unconstitutional. His firm continues to represent the over 400 petitioners in that case, over their mitigation hearings. He has attended death penalty conferences/workshops in Uganda, Kenya, and London. Prof. Ssempebwa has carried out extensive research and is widely published in journals and magazines.

He holds Bachelor of Laws (LL.B with honours) John F. Kennedy Scholar from the University of East Africa at Da-es-Salaam and a Master of Laws (LL.M) from the Queen's University, Belfast. He was President of East African Law Society (2002 – 2004); Member of the Committee of Experts for Review of the Kenya Constitution

(2009-2010); Chairperson of the Uganda Constitutional Review Commission (2001 – 2003); Commissioner of the Uganda Constitutional Commission (1989 – 1994); President of the Uganda Law Society (1990 – 1992); Minister of State, President's Office, 1979 – 1980; Associate Professor at the Makerere University, Kampala (1979-1984); Senior Lecturer at the University of Zambia (1977-1970); Lecturer at the University of East Africa, Dar-es-Salaam, 1970 – 1971; Senior Lecturer at the University of Zambia (1977 – 1979).
