He is currently a Lawyer in Khartoum from 1999, and Director of People's Legal Aid Centre (PLACE) From June 1998. The vision of PLACE is to improve access to justice for displaced women and children and to contribute towards bringing the Sudanese legal system in line with international human rights standards. As well as providing legal aid, in initiatives to bring Sudanese law in line with international standards, PLACE has brought cases through the legal system including the Constitutional Court and worked with governmental committees such as the National Council on Child Welfare (NCCW), the Legislation Committee on the Rights of the Child and the Legal Aid Acts as well as the Committee on the rights of prisoners.

He has provided consultancy with UNICEF Libya on mapping and analysis of child protection related legislation and policy frameworks in Libya from Nov 2012 to March 2013; consultancy on behalf of UNDP from Feb 2011 to March 2011 to support Juvenile Justice in Syria; consultancy with UNODC to conduct a Survey of legal Aid in North Africa from June 2010 to Sept 2010; advisor to UNICEF from June 2005 to 2009, on the legal protection work being carried out by its Child Protection section.
